TO HON. F. W. HARE, JUDGE OF CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN CHANCERY SITTING:-

## PART ONE

Comes now Theophilus M. Boykin, Plaintiff, and respectfully shows to the Court that he is a resident of Baldwin County, Alabama over the age of twenty-one years and that the Defendant Dazeree Dale Boykinis also a resident of Baldwin County, Alabama and over the age of twenty-one years.

#### PART TWO

- 1. The Plaintiff alleges that he and the Defendant were legally married in Mobile, Alabama the 1st day of August, 1923 and that both parties have been residents of the State of Alabama ever since said date and for more than three years prior to the filing of this bill and that both of said parties have been residents of Baldwin County, Alabama for more than three years.
- 2. ## PART FOUR

Plaintiff further prays that Your Honor will grant to him the Writ of Summons of the State of Alabama to be directed to the said

Dazeree Dale Boykin, thereby commanding her personally to appear before Your Henor in this Honorable Court within thirty days from the service thereof and then and there to answer to this Bill of Complaint and to stand to and abide such order and decree therein as to this Honorable Court shall seem meet; and Plaintiff shall ever pray &c.
