It is therefore CRDERED, ADJUDGED and DECREED by the Court that the bonds of matrimony heretofore existing between the complainant and the respondent be and the same are hereby dissolved and the complainant is forever divorced from the respondent on the ground of voluntary abandonment.

It is further CRDERED that the said Mamie A. Propst be and she is hereby permitted to again contract marriage upon the payment of the costs of court in this cause.

It is further CRDERED that the said Frank P. Propst pay the costs herein taxed, for which execution may issue.

It is further ORDERED, adjudged and DEORRED that the said Mamie A. Propst shall not again marry, except to the said Frank P. Propst, until sixty days after this date, and that if an appeal is taken within sixty days, she shall not marry again, except to the said Frank P. Propst, during the pendency of the appeal.

It is further ORDERED, ADJUDGED and DECREED that the said Frank P. Propst be and he is hereby permitted to again contract marriage upon the payment of costs in this cause.
