

Comes your Orator, Alexander Bertolla, humbly complaining of the Defendants as will hereinafter appear, and shows unto the Court and your Honor as follows:-

#### FIRST:

That he is over the age of twenty-one years and is a resident of Baldwin County. Alabama.

#### SECOND:

That the Defendants are over the age of twenty-one years and are residents of Baldwin County. Alabama.

#### THIRD:

Your Orator further shows unto your Honor that he is in the peaceable possession of the following described lands situated in Baldwin County, Alabama, to-wit:-

Southeast Quarter of the Northeast Quarter (SE2 of NE1) of Section Twenty-two (22), Township
Five (5) South of Range Two (2) East; less Sacrate Survey Communication to test the title to the same.

#### FOURTH:

Your Orator further shows unto your Honor that the Defendant, Laura Montgomery, is the owner of and in the peaceable possession of the following described lands in Baldwin County, Alabama. to-wit:-

East half of Northeast Quarter of the Southeast Quarter ( $E_2^1$  of NE $_2^1$  of SE $_2^1$ ) of Section Twenty-two (22). Township Five (5) South of Range Two (2) East;

That said Laura Montgomery has disposed of, or is attempting to dispose of one-half an acre in the Northeast corner of the East half of the Northeast Quarter of the Southeast Quarter of her lands, which are adjacent and contiguous to those occupied by your Orator, to certain parties who are building thereon a negro church and laying the grounds for a negro cemetery; that the lands of your Orator are chiefly valuable for building sites and (page one)

That there are other lands in the neighborhood available for the purpose of the building of a church and cemetery which may be obtained at or for the same price as that which the officers of the church are now attempting to purchase, and that no inconvenience will be worked to the church or to Laura Montgomery should the construction of said church and cemetery be restrained.

#### PRAYER FOR PROCESS.

To the end that equity may be had in the premises your Orator prays that your Honor will cause the usual Writ of Process to issue to Laura Montgomery/and the officers of said church restraining them from the construction or erection of said church and cemetery on said lands.
