The Plaintiff further avers that in, by and as a part of the note here sued upon the Defendant agreed to pay all costs of collecting or securing or attempting to collect or secure said note, including a reasonable attorney's fee, whether the same be collected or secured by suit or otherwise and Plaintiff avers that the sum of SEVENTY-FIVE & 00/100 (\$75.00) DOLLARS is such reasonable attorney's fee and Plaintiff claims of the Defendant the further and additional sum of \$75.00 as such attorney's fees.
