COUNT ONE

The plaintiff claims or the defendant FIFTEEN HUNDRED SIXTY-TWO & 28/100 (\$1562.28) DOLLARS due by promissory note made by him on the 23rd day of February, 1952, and payable on the first day of June, 1932, with interest thereon.

The plaintiff avers that in, by and as a part of the note here sued upon the defendant waived any and all homestead and exemption rights to which he may in any event be entitled under any provision of the Constitution or Laws, State or Federal, and of such waiver the plaintiff now claims the benefit.

COUNT TWO

The plaintiff claims of the defendant FOUR HUNDPER SIXTY NINE & 55/100 (\$469.55) DOLLARS, being the palance due by promissory note made by him on the 9th day of March, 1935, and payable on the first day of May, 1953, with interest thereon from May 25th, 1933.

The plaintiff avers that in, by and as a part of the note, sued upon in Count Three hereof, the defendant waived, as to said debt, all right of exemption as to personal property under the Laws of Alabama and of such waiver the plaintiff now claims the benefit.
