AT LAW.

The plaintiff claims of the defendant the sum of SEVENTY-FIVE DOLLARS (\$75.00) due by promissory note made by him on the 26th day of January, 1931, and payable sixty (60) days after date, with interest thereon, which said note is now the property of the plaintiff, liquidating the Consolidated State Bank, successor to the State Bank of Silverhill. The plaintiff admits the payment on said note of ELEVEN and 02/100 DOLLARS (\$11.02) on the 28th day of February, 1934.

The defendant, in and by said note, agrees to waive as to this debt, or any renewal thereof, all right to exemption under the Constitution and laws of Alabama, or any other state, as to personal property, and he agrees to pay all cost of collecting or securing, or attempting to collect or secure this note, including a reasonable attorneys' fee, whether the same be collected or

secured by suit or otherwise; and the plaintiff claims the benefit of said waiver.

And the plaintiff claims the further and additional sum of FIFTEEN DOLLARS (\$15.00) as a reasonable attorneys' fee in the premises.
