COMPLAINT

1. Plaintiff claims of the defendant SIXTEEN HUNDRED SEVENTY FOUR & 70/100 (\$1674.70) DOLLARS due by promissory note made by him on the 30th day of June, 1932, and payable on the 30 th day of September, 1932, with interest thereon.

2. The plaintiff avers that in, by and as a part of the note here sued upon the defendant waived as to this debt, all right of exemption under the Constitution and Laws of Alabama, or any other state, and of such waiver the plaintiff now claims the benefit.

3. Plaintiff claims of the defendant the further sum of TWO HUNDRED NINETY & 00/100 (\$290.00) DOLLARS, for that in, by and as a part of the note here sued upon defendant agreed to pay all costs of collecting or securing or attempting to collect or secure said note, including a reasonable attorney's fee, and plaintiff avers that said sum of TWO HUNDRED NINETY & 00/100 (\$290.00) DOLLARS is such reasonable attorney's fee WHEREFORE it claims the same.

That all of said sums are due and unpaid.
