The Plaintiffs claim of the Defendant Two Hundred Twenty-eight Dollars and Forty-six cents (\$228.46) due by promissory note made by him on the 30th day of June, 1965, and payable in installments of Twenty-five Dollars (\$25.00) monthly, the first installment being due and payable on July 15, 1965, with interest thereon. Such note provides that upon the failure to pay any payment on the due date the entire note shall become due and payable and the Plaintiff alleges that there was a failure to pay such installments as provided in said note.

The Plaintiffs aver that in, by and as a part of said note, the Defendant agreed to pay all costs of collection or attempting to collect said note, including a reasonable attorney's fee, whether the same be collected or secured by suit or otherwise and the Plaintiffs further claim of the Defendant the further and additional sum of Seventy-five Dollars (\$75.00) as such reasonable attorney's fee.

The Plaintiffs further aver that in, by and as a part of said note the Defendant waived as to this debt all rights of exemption under the Constitution and law of Alabama, or any other state, and of this waiver the Plaintiffs now claim the benefit.
