

3 of the Acreage Subdivision of Foley of Section 20, Township 7 South, Range 4 East, Baldwin County, Alabama, from Claude Petet by deed dated July 16, 1943, recorded in the office of the Judge of Probate of Baldwin County, Alabama, in Deed Book 80 N. S., at page 326, who acquired title from S. D. Gaar, by deed recorded 78 N. S., page 563, who acquired title from Dan Baker and wife by deed dated June 30, 1934, recorded in said office in 56 N. Complainant further alleges that he and those through whom he claims have for more than ten years next preceding the filing of said Bill of Complaint been in the actual, adverse possession of the said lands and have annually assessed and paid the taxes thereon and that during such period no other person has been in possession of said lands or any part thereof or assessed or paid taxes on said lands or any part thereon and that the Bill of Complaint is filed for the purpose of establishing his title to and interest in said lands and clearing up doubts and disputes concerning the same.

And it appearing from said Bill of Complaint, the same being duly verified that the names, ages and places of residence and post office addresses of the said defendants are unknown and cannot be ascertained upon diligent inquiry was made and the names, ages and places of residence and addresses cannot be ascertained.

It is therefore ordered, adjudged and decreed that notice of the pendency of said suit be given by publication once a week for four weeks consecutively in the Baldwin Times, a newspaper published in Bay Minette, in Baldwin County, Alabama.




