PETITION FOR THE REMOVAL OF DISABILITY OF NON-AGE
TO THE HONORABLE F. W. HARE, JUDGE OF SAID COURT:

Comes your Petitioner, William B. Schaeffer, Sr., and respectively represents unto your Honor and this Court as follows:

FIRST:

That he is a resident of the County of Baldwin, State of Alabama, and over the age of twenty-one years, and that he is the father of William Benard Schaeffer, Jr., who is a minor over the age of eighteen years and who resides with your Petitioner in Foley, Baldwin County, Alabama, and that said minor has no legal guardian.

SECOND:

Your Petitioner further shows unto your Honor that the said William Benard Schaeffer, Jr., is a veteran of World War II; that he wishes to enter into business; and that he wishes to take advantage of the loan benefits granted to veterans by the Service Men's Readjustment Act; and that your petitioner believes that it will be to the best interest of said minor to be relieved of the disability of non-age.

PRAYER FOR PROCESS AND RELIEF

THE PREMISES CONSIDERED, Your petitioner prays that your Honor will cause notice of this proceeding to be serviced on said minor as the rules of this Court and statutes in such cases provide; that your Honor will enter a decree relieving the said William Benard Schaeffer, Jr. of the disability of non-age; and that such different and further orders and decrees be made as may appear necessary in the premises so as to invest the said minor with the right to sue and be sued, contract and be contracted with, buy,

sell and convey real estate, and generally to do and perform all acts which he could lawfully do if he were twenty-one years of age, as your Petitioner will ever pray.

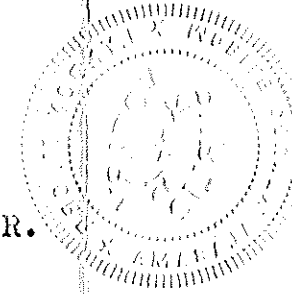

DECREE RELIEVING MINOR OF DISABILITIES OF NON-AGE

This cause coming on to be heard is submitted for decree on the petition and Ex Parte affidavits of W. B. Schaeffer and Samuel Elias, thereupon, upon consideration thereof, it is ordered, adjudged and decreed by the court that William Bernard Schaeffer, a minor, who is over the age of twenty years be and he is relieved of the disabilities of non-age, and she is vested with the power to sue and be sued, contract and be contracted with, to receive and take possession of any real and personal property to which he is entitled; to purchase real or personal estate, to sell and to convey, and to do all things; and to all intents and purposes as effectually as if he were twenty-one years of age.

IT IS FURTHER DECREED that the said William Bernard Schaeffer, pay the costs of the proceedings for which execution may issue.
