My name is Ernestine Thompson. I am over 21 years of age, and a bona fide resident of the State of Alabama, and have been all my life.

The Respondent, W. A. Thompson, is over 21 years of age and a bona fide resident of the State of Alabama; the respondent and I married in Mobile, Alabama, on August 29, 1946. We lived together as husband and wife in the State of Alabama, until on to-wit, November 14, 1946, and on other ocassions while we were living together as husband and wife threatened and abused me and often threated to do violence to my person which would necessarily endanger my life and health. The conduct of the Respondent was such as to give me every reasonable apprehension to believe and I did actually believe that if I continued to live with him he would carry out his threats and do actual violence to my person which would necessarily endanger my life and health. The Respondent and I have no community property.

I have tried hard to live with the Respondent and make a go of it,

Your Complainant, ERMESTIME THOMPSON, respectfully represents unto your Honor and this Honorable Court as follows:

1.

That your Complainant and the Respondent are both bona fide residents of the State of Alabama, and over 21 years of age.

2.

That your Complainant and the Respondent married at Mobile, Alabama, on August 29, 1946, and lived together as husband and wife until November 14, 1946.
