APPEAL BOND FROM JUSTICE OF PEACE COURT
HOWARD GAILLARD, Justice of Peace,
Beat 8, Baldwin County, Alabama.

We, Eliza Williams, as Principal, and the undersigned, as surety, are bound unto Wm. J. Russell in the sum of Two Hundred Dollars (\$200.00), for the payment of which we (jointly and severally) bind ourselves, our heirs, executors, and administrators.

Sealed with our seals, and dated the 8th day of July, 1937.

The condition of the above obligation is such that, on the 26th day of June, 1937, Howard Gaillard, a Justice of the Peace in and for said County, in Beat 8, rendered a judgment in favor of the said Wm. J. Russell, against the said Eliza Williams, for the possession of one yellowish ~~xxx~~ cow with black streaks in face, branded "C J", and increase, consisting of one red calf with white face, heifer; from which judgment the said Eliza Williams has appealed to the Circuit Court of Baldwin County, Alabama; if the said Eliza Williams shall prosecute said appeal to effect, or, if she fail in said appeal, shall pay such judgment, both as to debt and costs, as may be rendered against her by the said Circuit Court of Baldwin County, Alabama, then, in either of said events, this obligation to be void, otherwise to remain in full force and effect.
