Plaintiff claims of the defendant the sum of One Hundred and Eighty-six Dollars (\$186.00), due by a promissory note made by the defendants on, to-wit, June 10, 1937, payable in monthly installments of \$7.75 each, the first of which became due and payable on July 10, 1937.

Plaintiff avers that defendants defaulted in the payments due July 10, 1937 and August 10, 1937, respectively, and that under the provisions of said note, the entire amount of indebtedness is due and payable, which said sum of One Hundred and Eighty-six Dollars, with the interest thereon, is due and unpaid.

Plaintiff avers that under and by virtue of the terms of said promissory note, the defendants agree to pay a reasonable attorney's fee in the event said note should be placed in the hands of an attorney for collection. And plaintiff avers that it has become necessary to place said note in the hands of an attorney and that the plaintiff has incurred an attorney's fee of Thirty Dollars (\$30.00), which plaintiff alleges is a reasonable fee, and claims also of the defendants.

Plaintiff further alleges that under and by virtue of the terms of said note, the defendants waived all rights of exemption as to personal property under the constitution and laws of the State of Alabama.
