

AMENDED COMPLAINT.

The Plaintiff sues to recover possession of the following tract of land in Baldwin County, Alabama, to-wit: The (10) acres of land located in Section Twelve (12), Township Two (2) North, Range Two (2) East, bounded on the North and East by lands now or formerly owned by Silas Rice, on the South by lands now or formerly owned by Tony Brown, and on the West by lands now or formerly owned by Dick Williamson; being more particularly described as follows, to-wit:

From the Southwest Corner of Fractional Section 12, Township 2 North, Range 2 East, run North 1435 feet and North 80 degrees West 300 feet for a point of beginning; thence North 80 degrees West 485 feet; thence North 11 degrees West 619 feet to the South bank of Pine Log Creek; thence Northeasterly 800 feet, more or less up the South bank of Pine Log Creek to a point which is 300 feet West of the West line of said Section 12; thence South 1334 feet to the point of beginning, containing 10.9 acres, more or less, in Baldwin County, Alabama;
