The Plaintiff further claims of the Defendant the further and additional sum of Ninety-one & 72/100 Dollars (\$91.72), due by Promissory Note made by him on, to-wit, July 13, 1931, and payable on, to-wit, five (5) months after date, to the order of State Bank of Silverhill, together with interest thereon, and the Plaintiff avers that it is the owner of the aforesaid Note by having acquired the same for value.

The Plaintiff further avers that in and by the terms of said Notes the Defendant waived as to the debts secured thereby all right of exemption under the Constitution and laws of Alabama or any other state, as to personal property, and of this waiver the Plaintiff now claims the benefit.

The Plaintiff further avers that in and by the terms of said Notes, the Defendant agreed to pay all costs of collecting or securing or attempting to collect or secure said Notes, including a reasonable Attorney's fee, and the Plaintiff further claims of the Defendant the further and additional sum of Three Hundred Fifty Dollars (\$350.00), as such reasonable Attorney's fee.
