The Plaintiff claims of the Defendants One Hundred seventy-five Dollars (\$175.00), due by Promissory Note made by them on, to-wit, October 4th, 1937, and payable on, to-wit, in installments of Fifteen Dollars (\$15.00) per month, the first installment due November 5th, 1937, and one installment of Fifteen Dollars (\$15.00) on the 5th of each successive month thereafter until the full amount of said Note was paid, together with interest thereon.

Plaintiff alleges that in and by the terms of said Note the Defendants waived as to this debt all rights and relief under the Constitution or any exemption laws now in force or hereafter adopted or enacted in the State of Alabama, or in any of the other states, and of this waiver Plaintiff now claims the benefit.

Plaintiff further avers that in and by the terms of said Note the Defendants agreed to pay all reasonable costs and Attorney's fees that may be incurred in collecting or attempting to col-

lect this Note or any part of same, said Attorney's fees to be Fifteen Dollars (\$15.00), plus 15% of amount due thereon, if suit is filed against Defendant, and Plaintiff further claims of the Defendants the further and additional sum of Fifty Dollars (\$50.00), as such reasonable Attorney's fees.
