and whereas, the above bound ELLER S. 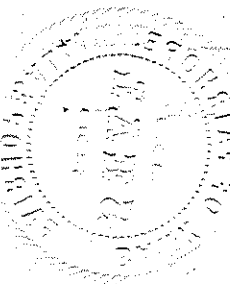
