GARNISHMENT ON JUDGMENT.

BALDWIN COUNTY

TO ANY SHERIFF OF THE STATE OF ALABAMA, GREETING:

WHEREAS, At a regular Term of the Circuit Court of Baldwin County, to-wit: On the 23rd day of August, 1933 being a regular day of said term Baldwin County Bank, a Corporation, recovered judgment against Bay Minette Land Company, a Corporation, for the sum of \$17,675.96, and cost of suit, and affidavit having been made by S. F. Holmes, President of said Baldwin County Bank, that process of garnishment is believed to be necessary to obtain satisfaction of such Judgment, and that the following named persons or corporations, viz: C. H. Bryars and/or V. O. McMillan has or is believed to have in their possession, or under their control money or effects belonging to said defendant, or that they are, or are believed to be indebted to said defendant, or to be liable to them, or to one of them on a contract for the delivery of personal property, or on a contract for the payment of money which may be discharged by the delivery of personal property or which is payable in personal property.

McMillan to be and appear before the honorable Circuit Court for Baldwin County, at the Court House thereof, in the City of Bay Minette, within thirty days from service of this writ, then and there to answer on oath, whether at the time of the service of the garnishment, or at the time making their answer, or at any time intervening the time of serving the garnishment and making the answer they were indebted to said defendant, and whether they will not be indebted in future to said defendant by a contract then existing, and whether by a contract then existing they are liable to said defendants for the delivery of personal property, or for the payment of money which may be discharged by the delivery

of personal property, or which is payable in personal property,  
and whether they have not in their possession or under their  
control money or effects belonging to the defendant, Bay Minette  
Land Company.
