TO THE HONORABLE F. W. HARE,

JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY:

Now comes your complainant HUBERT L. RHODES and presents this his bill of complaint against KATHERINE RHODES and shows unto your Honor as follows:

dent, Katherine Rhodes, are both over the age of twenty one years and that your Complainant and the Respondent were both bona fide residents of the State of Alabama, County of Baldwin at the time of separation and have been for a period of time next prior to the filing of this Complaint; that your Complainant is a resident of Baldwin County, Alabama and has been for a period of time proceeding the filing of this complaint and that your Respondent at the present time is a resident of Pensacola, Florida where she has been a resident since March 16th, 1937.

Rhodes were lawfully married in Pensacola, Florida on October 5, 1934 and lived together as man and wife until on or about March 16th, 1937 and further that there was born to the said marriage of complainant and respondent one child, namely Sharlyn Lee Rhodes, a girl who was born November 17th, 1935 and that at this time the said child is with your Respondent and your Complainant further shows into this Honorable Court that your Respondent is not a fit person to care for and to bring up this child and further that she has not the means with which to care for or educate the child in the manner in which she should be reared.

THIRD: Your Complainant further shows unto your Honor that during the month of February 1937 your Respondent did voluntarily without any cause or fault of your Complainant desert your Complainant and which offense he condoned and she returned to live with him and promised that she would never do so again and again on or about March 16, 1937 without any cause or fault on the part of your Complainant and against his will and desire while he was working in the field, your Complainant's mother-in-law came from the State of Florida, namely Pensacola, and enticed and carried away your Respondent and the child Sharlyn Lee Rhodes against the will and desire of your Complainant. Your Complainant alleges further that the Respondent was guilty of cruelty to your Complainant and neglected to care for and see after the duties and obligations which she owed to your Complainant and she refused to care for and discipline this child Sharlyn Lee Rhodes at all times and aleges further that she is an improper person to have the care and custody of this said child and that your Complainant be given the care, custody and control of this child for half time, six months at a time beginning with the decree in this matter and after the child becomes seven years of age that he be given absolute care, custody and control of the said Sharlyn Lee Rhodes.

PRAYER FOR PROCESS

that your Honor will take jurisdiction of the cause made by this bill of complaint and will cause notice thereof to be served on the Respondent, Katherine Rhodes, according to the rules of this Honorable Court and the laws of this State to such matters pertaining and make her respondent to the said bill of complaint requiring her to plead, answer or demur in the time allowed by law.

PRAYER FOR RELIEF

And your Complainant further prays that upon

the final hearing of this cause your Honor will grant him a decree dissolving the bonds of matrimony now existing between your Complainant and the Respondent, Katherine R hodes, and grant him an absolute decree, giving him the right of marriage again and giving him the care, custody and control of his child, Sharlyn Lee Rhodes for half time for six months period at a time and after the child becomes seven years of age that he be given absolute care, custody and control of the child, he being able to educate the child and care for her in the manner which would be proper according to her station in life, and your Complainant prays for such other and further relief as in equity and good conscience in the premises for which he will eyer pray.

The Respondent is required to answer but not under oath the same being hereby expressly waived as to each and every paragraph of the foregoing complaint numbered from one to four both inclusive.


