minor of 16 years of age, whose father is dead and who is  
residing with her mother, Daisy Long, was an occupant of an  
automobile driven by one J. S. Ford, which said automobile was be-  
ing driven in an easterly direction on the highway between Mobile  
and Bay Minette, Alabama, at a point approximately three miles  
East of the East end of Cochran Bridge, which said point is in  
Baldwin County, Alabama and said road being a public highway in  
Baldwin County, Alabama; at which said time and place said auto-  
mobile was run into, upon or against by an automobile, the proper-  
ty of the defendant, Alabama Water Service Company, which was negligently  
being driven by J. M. Godwin, an officer, agent or employee of  
the Defendant Alabama Water Service Company, at which time and  
place the said Godwin was acting within the line and scope of  
his said authority as such servant, agent or employee, and as a  
proximate result of said negligence of the defendants the plain-  
tiff was severely bruised, lacerated and shocked, and received a  
laceration on her face, her right ankle was sprained and other-  
wise injured; her teeth were dislocated and knocked out and her  
right eye was bruised, all of said injuries being of a permanent  
nature.

In the above matter Marguerite Long, a seventeen year old girl whose father is dead, was slightly injured in an automobile wreck which happened on September 4. We represent the Alabama Water Service Company and J. M. Godwin. Godwin was driving the car that was owned by Alabama Water Service Company. Messrs. Hybart and Chason represent the Plaintiff.

In order to settle the matter we have agreed to pay the Plaintiff seventy-five dollars, the court costs, doctors bills, and infirmary fee of five dollars. In view of the fact that Marguerite Long's father is dead her mother is her next friend and we have requested her attorneys to file suit in your court and to take a judgment for seventy-five dollars. We have consented for this judgment to be entered and this letter is for the purpose of giving you this information. When Messrs. Hybart and Chason ask for such judgment by consent we hope that you will enter it and we will then settle the matter at once.
