COUNT 1: The Plaintiff claims of the Defendant One Hundred Dollars (\$100.00) due by Promissory Note made by him on the 23rd day of July, 1938, payable on, to-wit, fifteen days after date, with interest thereon at the rate of 8% per annum from maturity.
