The Plaintiff claims of the Defendant the sum of One Hundred Sixty Dollars due by a promissory note originally for One Hundred Eighty Dollars, made by the Defendant on the 23rd day of February, 1938, and payable to the Plaintiff in monthly installments of Twenty-five Dollars per month, the first of which became due on March 23, 1938, and monthly thereafter and one installment for Thirty Dollars payable on September 23, 1938, which said note is the property of the Plaintiff and is still due and unpaid, together with the interest thereon from September 23, 1938. The Plaintiff further avers that in and by the terms of the said note the Defendant waived all rights of exemption as to this debt and also agreed to pay a reasonable attorney's fee for the collection of same, which said attorney's fee the Plaintiff alleges to be Twenty-five Dollars, and which he herewith claims.
