The Plaintiff claims of the Defendant ONE HUNDRED FIFTEEN & 00/100 (\$115.00) DOLLARS due by Promissory Note made by him on, to-wit, February 18th, 1939, and payable on, to-wit, one year after date with interest thereon at the rate of six percent (6%) per annum from date.

The Plaintiff avers that in and by the terms of said Note the Defendant waived as to this debt all right of exemption under the Constitution and Laws of Alabama or any other State, and of this waiver the Plaintiff now claims the benefit.

The plaintiff further avers that in and by the terms of said Note the Defendant agreed to pay all costs of collecting or securing or attempting to collect or secure said Note, including a reasonable Attorney's fee, and the Plaintiff further claims of the Defendant the further and additional sum of TWENTY-FIVE DOLLARS (\$25.00) as such reasonable Attorney's Fee.


