The Plaintiff claims of the Defendant the sum of Four Hundred Forty Nine & 68/100 Dollars (\$449.68) due by Promissory Note made by him on to-wit, July 25, 1931 and payable on to-wit, October, 27, 1931, to the order of the Robertsdale State Bank of Robertsdale, Alabama, together with interest thereon at the rate of six per-cent (6%) from October 27, 1931, which sum of money, together with the interest thereon, is still due and unpaid.

The Plaintiff avers that said note, together with the debt evidenced thereby, for a valuable consideration, was duly transferred and assigned to, and is now the property of, the Plaintiff.

The Plaintiff avers that in and by the terms of said note the Defendant waived as to this debt, or any renewal thereof, all right to exemption under the Constitution and laws of Alabama or any other State, as to personal property, and of this waiver the Plaintiff now claims the benefit.

The Plaintiff further avers that in and by the terms of said note the Defendant agreed to pay all costs of collecting or securing, or attempting to collect or secure, this note, including a reasonable attorneys' fee, whether the same be collected or secured by suit or otherwise, and the Plaintiff further claims of the Defendant the further and additional sum of One Hundred Thirty-five Dollars (\$135.00), as such reasonable attorneys' fee.
