The Plaintiff claims of the Defendants SEVEN HUNDRED FORTY (\$740.00) DOLLARS, due by promissory waive note made by them on the 12th day of December, 1940, and payable as follows: FOUR HUNDRED TWENTY-SIX AND 87/100 (\$426.67) DOLLARS on or before June 1, 1941; and THREE HUNDRED THIRTEEN AND 33/100 (\$313.33) DOLLARS on or before June 1, 1942, with interest thereon at eight per cent per annum from maturity.

The Plaintiff admits a credit on said note of ONE HUNDRED FORTY-ONE (\$141.00) DOLLARS as of August 24, 1942.

The Defendants waived all exemption as to personal property, and agreed to pay all costs and expenses in connection with the collection of said note.

The Plaintiff claims of the Defendants the further sum of ONE HUNDRED FIFTY (\$150.00) DOLLARS as a reasonable attorney's fee.


