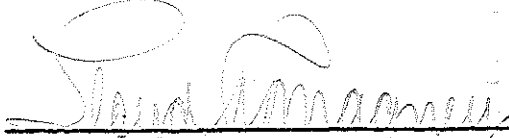

The Plaintiff claims of the Defendant ONE HUNDRED FORTY (\$140.00) DOLLARS due by promissory waive note made by her on the 25 day of January, 1941, and payable on the 1 day of September, 1941, with interest thereon at eight per cent per annum from maturity.

The Plaintiff admits a credit on said note of SEVENTY-FIVE (\$75.00) DOLLARS as of August 24, 1942.

The Plaintiff claims of the Defendant THREE HUNDRED SEVENTY-FIVE (\$375.00) DOLLARS due by promissory waive note made by her on the 6 day of May, 1941, and payable as follows: ONE HUNDRED (\$100.00) DOLLARS on or before December 1, 1941, and TWO HUNDRED SEVENTY-FIVE (\$275.00) DOLLARS on or before May 1, 1942, together with interest thereon from maturity at eight per cent per annum.

The Plaintiff admits a credit on said note of SEVENTY-FIVE (\$75.00) DOLLARS as of August 24, 1942.

The Defendant in said note waived all exemption as to personal property, and agreed to pay all costs and expenses of collecting said-

note.

The Plaintiff claims of the Defendant the further sum of SEVENTY-FIVE (\$75.00) DOLLARS as a reasonable attorney's fee.
