truth, the whole truth, and nothing but the truth, the said <u>Raleigh McKenzie</u>
doth depose and say as follows:
My name is Raleigh McKenzie. I live at Barnwell, in Baldwin County, Alabama, where I have lived all my lifetime. I am over twenty-one years of age.
The Respondent, Ivola McKenzie, is over twenty-one years of age and lives at Barnwell, in Baldwin County, Alabama. At the time the suit was filed in this cause, she was temporarily sojourning at Lincoln Park, Michigan, her present Post Office Address being 1564 Anne Street. I understand that she is at present in Mobile, Alabama.
Ivola McKenzie and I were married in Mobile, Alabama, in October, 1918, and we lived together as husband and wife, at or near Barnwell, in Baldwin County, Alabama, until August 4th, 1937.
For some unknown reason, the Respondent, Ivola McKenzie, about a year ago,-
or a little longer, began drinking and kept it up from time to time until about three or four months before she left when it got to the point that she stayed under the influence of liquor practically all the time. The condition grew worse from time to time. When she would go on one of these drinking spells, she would leave home and stay gone at first a day or two at a time and then along toward the last for a week or more at a time until finally in August, after being on a drunk for about a week or more, she left and hasn't been back since.
