
COMPLAINT

1. The Plaintiff claims of the Defendant TWO HUNDRED THIRTY & 00/100 (\$250.00) DOLLARS, the balance due by promissory note, made by him on the 3rd day of April, 1942, and payable on the 1st day of June, 1942, with interest thereon.

2. The Plaintiff avers that in, by and as a part of the note here sued upon, the Defendant waived all right to exemption under the Laws of the State of Alabama, and of such waiver, Plaintiff now claims the benefit.

3. The Plaintiff further avers that in, by and as a part of the note here sued upon, the Defendant agreed "Should this note be unpaid at maturity and placed in the hands of an attorney for collection, then there shall also become due, as a part of the principal hereof, reasonable attorneys fees." The Plaintiff further avers that said note was unpaid at maturity and also placed in the

hands of an attorney for collection and that the sum of FORTY DOLLARS (\$40.00) is a reasonable attorney's fee and the Plaintiff claims the further and additional sum of FORTY DOLLARS (\$40.00) as such attorney's fee.
