On the 29th day of September, 1947, came the Plaintiff by its attorney and made proof that an Affidavit was made by the Plaintiff at the commencement of this suit, that the Defendant was a non-resident of the State of Alabama and resided at 937 Adams Street, Ocala, Florida. 
