Yukers, the sum of \$258.12 for the payment of which a lien is hereby established on the said NE2 of the SE2 and the SE2 of the NE2 of Section IO, TEXX T55, R2E, Baldwin County Ala., and the same is hereby ordered condemned and sold for the satisfaction of this judgement and the enforcement of the lien in the manner prescribed by law, the proceeds of said sale to be applied, first, to the payment of costs in this case, second, to the satisfaction and discharge of this judgement and lien, with the balance, if any, remitted to the Defendant.

I. The plaintiff, W.C. Mattingly, claims of the defendant, Jackie B. II. The plaintiff, W.C. Mattingly, claims of the defendant, Jackie B. Yukers, the sum of \$250.00 with interest for that: On, to-wit, March I, 1947, he contracted with the defendant, for an agreed hourly rate, to clear portions, in the aggregate 20 acres more or less, of the following described land;

the property of defendant; That pursuant to said contract the plaintiff entered on said land and cleared the same, beginning on or about March 3, 1947 and finishing on or about March 14, 1947; That there remains past due and unpaid to plaintiff a balance of \$250.00 for said work which defendant has failed and refuses to pay after demand therefore;
And plaintiff further avers that, in compliance with the statute in such cases made and provided, and within six months after the accrual of said indebtedness, he has, heretofore, on to-wit, April I, 1947, filed for record in the Probate Office of Baldwin County Alabama a Verefied Statement Claiming Lien on the above described property, said Statement being verefied by oath of the plaintiff having personal knowledge of the facts stated therein, containing the amount of plaintiff's demand after all credits had been given together with a description of the property on which the lien is claimed in such manner that same may be identified or located and containing the name of Jackie B. Yukers, Owner.
Wherefore plaintiff prays judgement against the defendant for \$250.00 with interest and claims a lien on the property herein described and prays that it be established.
