- 1 walking cultivator.
- 1 Ga. stock
- 3 Duroc brood sows about 18 months old.

Now, if the said A. G. Allegri shall fail in the said suit and shall pay to the said Jasper Longmire all such costs and damages as he may sustain from the wrongful complaint, then this obligation to be void, other wise to remain in full force and effect.


