The plaintiff claims of the defendant the sum of  
One Hundred Eighty One and 09/100 (\$181.09) Dollars due by  
installment promissory note made by him on to-wit, the 9th  
day of March, 1943, and due and payable in installments as  
follows; \$61.09 on June 10th, 1943, \$60.00 on July 10th, 1943,  
and the last installment of \$60.00 on August 10th, 1943 with  
interest thereon.

Plaintiff avers that by and under the terms of said  
note, the defendant agreed that in the event he failed to  
promptly pay any installment on the date that the same ma-  
tures, then the entire unpaid principal and interest shall  
immediately become due and payable, and plaintiff avers that  
the defendant failed to pay the installments due and payable  
on June 10th, 1943 and July 10th, 1943, respectively and that  
said installments still remain due and unpaid.

Plaintiff further avers that he has elected to declare  
and does now declare the entire principal and interest as  
evidenced by said note immediately due and payable.

The plaintiff further claims of the defendant the  
sum of Twenty-Seven and 15/100 (\$27.15) Dollars, as a  
reasonable attorney's fee as agreed to by the defendant  
and provided for by and under the terms of said install-  
ment promissory note.

And Plaintiff further avers that the defendant, as to  
the debt evidenced by said installment promissory note, and under the  
terms thereof, waived all right of exemption to personal property author-  
ized by the Constitution and Laws of the State of Alabama,
