COUNT 1.

The Plaintiff claims of the Defendants One Hundred Dollars (\$100.00) due by Promissory Note made by them on December 13, 1940, and payable on to-wit; December 1st, 1941, with interest thereon.

The Plaintiff alleges that in, by and as a part of said note the Defendants waived all claims of exemption under the Constitution and laws of the State of Alabama and of this waiver the Plaintiff now claims the benefit.

The Plaintiff further alleges that in, by and as a part of said note the Defendants agreed to pay a reasonable attorney's fee and all costs and expenses of collection of said note, and the Plaintiff further claims of the Defendants the further and additional sum of Twenty-five Dollars (\$25.00) as such reasonable attorney's fee.

COUNT 2.

The Plaintiff claims of the Defendants Forty-

eight and 92/100 Dollars (\$48.92) due from them by account on to-wit; the 31st day of January, 1942, which sum of money, together with interest thereon, is still due and unpaid.

COUNT 3.

The Plaintiff claims of the Defendants Forty-eight and 92/100 Dollars (\$48.92) due from them on account stated between the Plaintiff and the Defendants on to-wit; the 31st day of January, 1942, which sum of money, together with interest thereon, is still due and unpaid.

COUNT 4.

The Plaintiff claims of the Defendants the sum of Forty-eight and 92/100 Dollars (\$48.92) due from them for merchandise, goods and chattels sold by the Plaintiff to the Defendants on to-wit; from August 29, 1941 to January 31, 1942, which sum of money, together with interest thereon, is still due and unpaid.
