

The Plaintiff claims of the Defendant the sum of One Hundred Sixty-five and 60/100 Dollars (\$165.60) due by Promissory Note made by him on to-wit, August 23, 1943, and payable in equal installments of Forty Dollars (\$40.00), the first of said installments being due on to-wit, September 20, 1943, and a like installment on the 20th of each month thereafter until said sum has been paid in full, which sum of money, together with interest thereon is due and unpaid.

The Plaintiff avers that in, by and as a part of said Note the Defendant waived as to this debt the rights and relief under the Constitution of any exemption laws now in force or hereafter adopted or enacted in the State of Alabama, and of this waiver the Plaintiff now claims the benefit.

The Plaintiff further avers that in, by and as a part of said Note the Defendant agreed to pay all reasonable costs including attorneys' fees that may be incurred in collecting or attempting to collect this Note or any part of the same, said Attorneys' fees

to be fixed at 15% of the amount unpaid hereon when placed in the attorneys' hands for collection, if no suit is brought thereon, but if suit is brought said Attorneys' fees shall be 15% plus Fifteen Dollars (\$15.00). And the Plaintiff further claims of the Defendant the further and additional sum of Fifty Dollars (\$50.00) as such reasonable Attorneys' fees.
