

Your Complainant, Ora Lee Keel, respectfully represents unto your Honor and this Honorable Court as follows:

That your Complainant is over twenty-one years of age, and a resident of Robertsdale, in Baldwin County, Alabama; that the Respondent is over twenty-one years of age and a resident of Jefferson County, Alabama, his address being 224-50th Street, Fairfield, Alabama.

That your Complainant and the Respondent married at Bay Minette, in Baldwin County, Alabama, on May 27, 1934; that they lived together as husband and wife until on, to-wit, January 1, 1946; that they were living at Roberts-dale in Baldwin County, Alabama, at the time of the commission of the acts herein after complained of and at the time of the separation.

That on, to-wit, January 1, 1946, the Respondent threatened and abused the Complainant, and threatened to do actual violence toher person which would necessarily endanger her life and health. That the conduct of the Respondent was such as to give the Complainant every reasonable apprehension to belive, and she did actually believe that if she continued to live with the Respondent he would carry out his threats and do actual violence to her person which would necessarily endanger her life and health.

That there was born between the marriages of the said Complainant and Respondent one child, Beverley Ann Keel, eleven years old, who is now with the Complainant; that your Complainant is a suitable, fit and proper person to have her care, custody and control.

WHEREFORE, the premises considered, Complainant prays that your Honor will by proper process make the said Louis J. Keel party Respondent to this cause of action, requiring her to plead, answer or demur to the same within the time and under thepenalties prescribed by law and the practice of this Honorable Court.

The Complainant prays that your Honor will, upon a hearing hereof, enter an order and decree, granting to her an absolute decree of divorce, forever barring the bonds of matrimony existing between her and the Respondent; that she be awarded the custody of the minor child, Beverley Ann Keel; that she be granted such other, further, different, or general relief as she may be in equity and good conscience entitled to receive, and as in duty bound she will ever pray.
