The Plaintiff claims of the Defendant the sum of SEVEN HUNDRED FIFTY DOLLARS as damages for this that heretofore on, to-wit, the 3rd day of May, 1947, the Defendant negligently drove an automobile into the side of the frame building located at the Southwest corner of the Daphne-Loxley Highway and that road formerly known as the Bay Minette Highway in the Community of Belforest, Baldwin County, Alabama, and as a proximate result of said negligence and of the impact of said car on said building the East wall thereof was broken in and seriously damaged the framework and roof of the building racked and damaged to the amount of the damages aforesaid, which sum, with the interest thereon is still due and unpaid.
