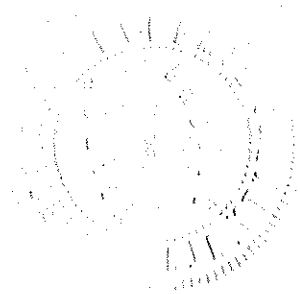

CIRCUIT COURT

TO ANY SHERIFF OF THE STATE OF ALABAMA - GREETING:

Whereas, heretofore, on the 6th day of February, 1948, Camilla N. Hooper did recover of Willie Cox a judgment for the sum of One Hundred Forty-Six Dollars and Fifty Cents (\$146.50) and costs in the Circuit Court of Baldwin County, Alabama, and whereas the said Camilla N. Hooper has made Affidavit as required by law that the said judgment is unpaid and that there is owing thereon the sum of \$146.50 and costs of court, and the process of garnishment is believed to be necessary to obtain satisfaction of such judgment, and that the Louisville and Nashville Railroad Company, a corporation, is believed to be chargeable as garnishee.

YOU ARE THEREFORE, commanded to summon the said Louisville and Nashville Railroad Company, a corporation, to be and appear within thirty days from the service of this writ, in the Circuit Court of Baldwin County, Alabama, then and there to answer, upon oath, whether, at the time of the service of this garnishment, or at the time of making your answer, or at any time intervening between the time of serving the garnishment and making the answer, you were indebted to the defendant, and whether, you will not be indebted to him in the future by a contract then existing, and whether by a contract then existing, you are liable to him for the delivery of personal property, or for the payment of money which may be discharged by the delivery of personal property, or which is payable in personal property, and whether you have not in your possession or under your control money or effects belonging to the defendant.
