

CIRCUIT COURT

TO ANY SHERIFF OF THE STATE OF ALABAMA - GREETING:

Whereas, heretofore, on the 6th day of February, 1948, Camilla N. Hooper did recover of R. C. Mims a judgment for the sum of One Hundred Thirty-Three Dollars (\$133.00) and costs in the Circuit Court of Baldwin County, Alabama, and whereas the said Camilla N. Hooper has made Affidavit as required by law that the said judgment is unpaid and there is owing thereon the sum of \$116.50, balance due on that certain judgment, and the process of garnishment is believed to be necessary to obtain satisfaction of such judgment, and that Murray Crim is believed to be chargeable as garnishee.
