TO THE HONORABLE JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY.

Comes your Complainant John Bestor Robertson who is over the age of 21 years and a resident of Mobile County, Alabama, and exhibits this his bill of complaint against Emma Poplin Wright who is also over the age of 21 years and is at present residing at Fairhope, Baldwin County, Alabama. Complainant respectfully shows unto the court as follows:-

1.

That he is the lawful owner of the following tract of land situate in Baldwin County, Alabama, viz:

Lots 10, 11, 12, 13, 15 and 16, Sea Cliff Subdivision in Section 8 Township 6 South, Range 2 West, according to the map thereof recorded in the Probate Court of Baldwin County, Alabama.

2.

That on December 23rd, 1935, Honorable H. M. Wilkins, as Sheriff of Baldwin County, executed to the respondent herein a sheriff's deed conveying all of complainant's interest in said property to the respondent to satisfy a judgment obtained in the Circuit Court of Baldwin County. Said deed is recorded in Deed Book 58 page 458 Probate Records of Baldwin County, Alabama.

3.

That the complainant has offered to redeem said property from said sheriff's deed but that respondent herein has refused to permit such redemption.

4.

Complainant is ready, able and willing to redeem said property as soon as he is informed of the correct amount of the redemption and hereby offers to pay into Court whatever sum may be ascertained by the Court to be due the respondent in order to redeem said property.

PRAYER FOR PROCESS

The premises considered the complainant prays the Court to take jurisdiction of this cause and have its process issue to the respondent commanding her to plead, answer or demur to this bill of complaint within the time required by law.

PRAYER FOR RELIEF

And Complainant further prays unto the Court that upon a final hearing of this cause the Court will ascertain and determine the amount of money necessary to redeem said property from said sheriff's deed and will order the respondent to reconvey said property unto the Complainant upon the payment into Court of such sum as may be ascertained to be due. Complainant prays for all such other, further and different relief as he may be in equity entitled to receive the premises considered.
