

COUNT ONE: Plaintiff claims of the Defendant the sum of TEN THOUSAND DOLLARS damages for that on, to-wit, May 6th, 1945, the Defendant so negligently operated an automobile into and across a public highway in Baldwin County, Alabama, and in the Town of Bay Minette, Alabama, to-wit, U. S. Highway 31, that he ran the same into a truck, the property of the Plaintiff, in which the Plaintiff was then and there riding, and Plaintiff says that as a proximate consequence of the negligence of the Defendant as aforesaid his truck was badly wrecked and damaged, and Plaintiff sustained a severe fracture of the arm, or collar bone, a severe injury to his back, was otherwise bruised, hurt, made sick and sore, was caused to suffer great pain and mental anguish, to lose much time from his work, to incur great expense in and about the healing and treatment of his said injuries, and has been permanently injured; all as a proximate consequence of the negligence of the Defendant as aforesaid; WHEREFORE, he sues.
