The Plaintiff, Charles W. Parish, a minor, who sues by and through his next friend, Z. A. Parish, Sr., claims of the Defendant, Robert Cochran, the sum of five thousand dollars, damages, for that heretofore on to-wit June 12, 1948, plaintiff was being transported, as a guest, in an automobile being driven by the defendant, and while being so transported over or along the public highway of Baldwin County, Alabama, at or near the point of intersection of the Robertsdale and Mobile Highways, approximately one mile North of Fairhope, Alabama, defendant so operated said automobile so as to cause the same to leave the highway and wantonly caused plaintiff to be thrown through the windshield of said automobile and receive the following injuries: Plaintiff's pelvis was broken in two places, plaintiff received cuts and bruises on his arms, legs and other parts of his body and was caused to suffer great physical and mental pain and anguish, and was caused to spend great sums of money for medicine, medical care and nursing in and about his efforts to heal and cure his said wounds and injuries.

And Plaintiff avers that his said injuries were proximately caused by the willful or wanton misconduct of the defendant in and about the operation of said automobile at the time and place aforesaid.


