Your Petitioner Frank Carroll, respectfully represents unto your Honor and this Honorable Court as follows:

1.

That he is imprisoned in the County Jail of Baldwin County, Alabama, by Honorable Taylor Wilkins, Sheriff of Baldwin County, Alabama, on a charge of assault with a weapon, issued out of the Circuit Court of Baldwin County, Alabama; that a copy of said indictment and the alias capias under which he is held are hereto attached marked exhibits A and B, and ask to be taken as a part hereof.

2.

That your petitioner is illegally restrained of his liberty.

3.

That your petitioner was tried and convicted by the City Court of Bay Minette, Alabama, a court of competent jurisdiction with the same offense for which he was indicted to-wit:

Assault and battery on one Robert Jackson;

That the fine and costs were paid in and to the said City Court, of Bay Minette, Alabama, prior to the date of the indictment at the Spring session, 1948, of the Circuit Court of Baldwin County, Alabama; that said cause is Number 1559, on the City Court record of the town of Bay Minette, Baldwin County, Alabama, and shows that the fine and costs were paid on January 5, 1948, \$35.35 and on January 12, 1948, \$21.50, making a total of Fine cost, for the offense of assault with a weapon of \$56.85.

Your Petitioner further alleges that the offense for which he was convicted in the City Court of the town of Bay Minette, Baldwin County, Alabama, was based upon the same facts and the offense charged were the same and indentical as those for which the indictment was returned at the Spring sesseion, 1948, of the Circuit Court of Baldwin County, Alabama.
