The petition of Dorothy Louise Buzbee, who is over the age of nineteen years and who is a resident citizen of Baldwin County, Alabama, respectfully shows and represents unto your Honor;

#### Rivet .

That she is the mother of Ellen Louise Buzbee and Joyce Harie Buzbee, who are now restrained in the custody of Leslie Buzbee and Mildred Roberts, illegally.

#### Second.

That the children of foresaid are infants of tender years being: Ellen Louise Buzbee ten months of age and Joyce Marie Buzbee two years of age, and that the proper party to have the custody and care for these infants would be their mother, your Petitioner, and that such restraint of said children away from the mother, your Petitioner, is against the welfare of said children inasmuch as said children were taken from your Petitioner's custody and control by force and against the will and wishes of your Petitioner.

## Third.

That the youngest child was taken by force, intimidation and the display of a pistol in a threatening manner on to-wit, October 15th the older child was taken a short time prior thereto.

## Fourth.

That said infants are fruits of a marriage between your Petitioner and Leslie Buzbee and that the said Leslie Buzbee is over the age of twenty-one years, as is the other Respondent in said cause, Mildred Roberts. The said infants are at present in the custody and control of the named Respondents.

Your Petitioner prays that a writ of habeas corpus be issued, directed to said Leslie Buzbee and Mildred Roberts, commanding them to bring the bodies of said infants before your Honor at the time and place to be by you appointed, together with the cause of said infants.
