PETITION FOR APPROVAL OF A LUMP SUM SETTLEMENT FOR INJURED EMPLOYEES UNDER WORKMAN'S COMPENSATION

TO THE HONORABLE TELFAIR J. MASHBURN, JR., JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA:

The undersigned, being the only parties in the above entitled matter, hereby petition the Court for approval of the following agreement and settlement and agree and represent to the Court as follows, viz:-

That the employee and employer are subject to the provisions of the workman's compensation laws of the State of Alabama; that the Hartford Accident & Indemnity Company, a corporation, is the insurer of the employer; that the said employee, aged 29, residing at Robertsdale, Baldwin County, Alabama, who can read and understand the English language, did on the 10th day of October, 1949, on or about 3:30 o'clock p.m. sustain an injury while employed by said employer, which injury occurred at Robertsdale, Alabama, and resulted in loss of time from employment, certain pain, suffering, etc. on the part of the employee. The employee was received, at the time of injury, wages at the rate of Thirty Dollars (\$30.00) per week, therefore, it is hereby agreed that the employee is entitled to and shall receive compensation for said injury in a lump sum settlement in accordance with the workman's compensation laws of the State of Alabama in the extent of One Hundred Fifty Dollars (\$150.00).

The employee acknowledges that he has received to date medical and surgical treatments and agrees that no further treatments are necessary or required and that no additional treatments or benefits shall be furnished as a result of this injury. The parties further agree that there is no permanent disability as a result of this injury and employee agrees that the settlement as herein provided is reasonable and just under the circumstances and agrees, and so states, that there is grave doubt as to there being a liability on the part of the employer under the workman's compensation laws of the State of Alabama due to the nature of the injury and acknowledges

that settlement made and agreed upon in this petition is not an acknowledgment of liability on the part of the employer or the insurer of the employer.

This petition and settlement contains the entire agreement between the parties and is to be considered, upon its approval, full settlement of all liability.


