





The plaintiff claims of the defendant Two Hundred Thirty Dollars ( \$230.00) due by Promissory Note made by him on, to-wit, March 29, 1947, and payable on May 1st, 1947, with interest at the rate of six per cent (6%) per annum from the 1st day of May, 1947.

The plaintiff avers that in and by the terms of the said note, the defendant waived all right to exemption under the Constitution and Laws of Alabama or any other state as to personal property and of this waiver the plaintiff now claims the benefit.

The plaintiff further avers that in and by the terms of said note, the defendant agreed to pay all cost of collecting or securing or attempting to collect or secure this note, including a reasonable attorney's fee, and the plaintiff further claims of the defendant the further and additional sum of Forty-five Dollars ( \$45.00) as such reasonable attorney's fee.


