TO ANY SHERIFF OF THE STATE OF ALABARA:

You are hereby commanded to summon W. D. POWELL to appear within thirty days from the service of this writ in the Circuit Court, to be held for said County at the place of holding the same, then and there to answer the complaint of J. L. WALTER.

Witness my hand, this 17th day of August, 1951.

The Plaintiff claims of the defendant FIVE HUNDRED (3500.00) DOLLARS as damages, for that heretofore on to-wit, april 18, 1951, the Plaintiff was operating his automobile along United States highway 31, at a point approximately one and one half miles (1½) North of the court house at Bay Minette, in Baldwin County, Alabama, and at said time and place the Defendant W. D. Powell, acting by and through his agent, servant or employee who was then and there acting within the line and scope of his employment negligently drove an automobile into or against the automobile of the Plaintiff, and as a proximate result of said negligence on the part of the Defendant acting by and through his agent, servant or employee who was then and there acting within the line and scope of his employment, the Plaintiff's automobile was knocked off of the highway; the fenders were bent; the body was bent; the frame was bent; the hood was bent; the wheels were bent; and the said car was otherwise damaged, hence this suit.

The Plaintiff claims of the Defendant the further sum of CNE THOUSAND (\$1000.00) DCHLARS as damages for that heretofore on to-wit, April 13, 1951, the Plaintiff was operating his automobile along highway 31 in Baldwin County, Alabama, at a point approximately one and one half miles (12) North of the court house at Bay Minette and at said time and place

The Defendant acting by and through his agent, servant or employee negligently drove an automobile into or against the automobile in which the Plaintiff was riding and as a proximate result thereof the Plaintiff received personal injuries and damages as follows: that he was cut on the right cheek; that he was cut and brusied on the head; that his right arm was injured; that his right side was injured; that he was injured internally; that his right knee and leg were injured; that he was permanently injured; that he was caused to lose time from his work; that he incurred doctor and medical bills.

The Plaintiff alleges that his injuries and damages were the proximate result of the negligence of the Defendant acting by and through his agent, servant or employee who was then and there acting within the line and shope of his employment.
