Plaintiff claims of the defendant the sum of Twenty Five Hundred and no/100 (\$2500.00) Dollars, as damages in this that heretofore on, to-wit, the 4th day of June, 1951, the defendant so negligently operated a motor vehicle southwardly on an unnamed county road at or near its intersection with the Barnes Road, both of which are public highways in Baldwin County, Alabama, as to cause or allow said motor vehicle to collide with or run against the automobile of the plaintiff which was then being driven in an eastwardly direction along said Barnes Road and as a proximate consequence thereof, plaintiff's automobile was badly bent, broken and damaged, portions of it were demolished, and it was rendered unfit for the uses for which it was constructed, the plaintiff lost the use of it for a long period of time and was forced to secure the use of a substitute vehicle, all to his injury, hence this suit.


