THIRD: That since she left Complainant said Geneva
McConnico has been guilty of adultery with some man or men unknown to Complainant as shown by the fadt that she has recently
given birth to a child with whose parentage Complainant has no part.

FOURTH: That there was born to this marriage two other children, one of whom has since died and the survivors reside with their mother near Montrose.

THE PREMISES CONSIDERED, Complainant prays that Geneva D. McConnico be made party defendant to this bill and that due process these notifying her to answer same within the time prescribed by law.

COMPLAINANT FURTHER PRAYS that upon the hearing of this cause a decree be rendered forever divorcing him from the said Geneva D. McConnico giving him the right to marry again should he so desire and such other further and different melief as to equity shall seem meet.
