## JUDGEMENT

This cause coming on to be heard was presented on petition of habeas corpus filed by Leamuel Rider as next friend of Linda Faye Richardson and was a petition to establish custody of the said Linda Faye Richardson, a minor. The parties appearing in open court were informed by the Judge of said Court that the court would consider any matters pertaining to and affecting the best interest of the minor child, Linda Faye Richardson, therefore the parties to this cause with permission of the court withdrew in an attempt to agree as to how the best interest of said minor child could be served. The parties to this cause reported to the court that they had agreed that the best interest of the child could be served by custody of said minor child being now given to Leamuel Rider, the uncle of the minor child, Linda Faye Richardson, and the court being convinced that the best interest of the minor child would be served thereby,

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that custody and control of Linda Faye Richardson, a minor, is hereby granted to Leamuel Rider, her uncle, pending such time as Ernest Richardson, the father of said minor, is able to remain at home with said minor and has a suitable and proper place for the said minor to reside in such surroundings as would tend to satisfy completely her moral and physical needs.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that Ernest Richardson, the father of Linda Faye Richardson, shall have reasonable rights of visitation at all proper times.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Court retain jurisdiction of this case pending such other and further orders as may from time to time seem just and proper.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Linda Faye Richardson through Leamuel Rider, her next friend, pay all cost of court for which let execution issue.
