### TO THE HON. F. W. HARE, JUDGE OF THE CIRCUIT COURT, IN BALDWIN COUNTY, ALABAMA, IN CHANCERY SITTING:

### PART ONE

Come now Katharina Staimpel and Martin Staimpel and respectfully show to the Court, that they and each of them are over the age of 21 years, and residents of Baldwin County, Alabama, and that the Respondent, Baldwin County Colonization Company is a corporation organized and existing under the laws of the state of Alabama, but with no place of business in the state of Alabama.

### PART TWO

The Complainants aver that they are in the peaceable possession, claiming to own the same, of the following described lands in Baldwin County, Alabama, to-wit:-
